TCEQ received this application on May 31, 2018. The facility is located at 12603 Wellington Parkway in Harris County, Texas 77014. The treated effluent is discharged to Harris County Flood Control District (HCFCD) ditch P145-00-00, thence to Greens Bayou Above Tidal in Segment No. 1016 of the San Jacinto River Basin.
