No. TX0138616) to authorize the discharge of treated wastewater at a volume not to exceed a daily average flow of 39000 gallons per day. The domestic wastewater treatment facility is located approximately 2.8 miles west northwest of the intersection of Foley Road and Farm-to-Market Road 2100, in Harris County, Texas 77532. The discharge route is from the plant site to an unnamed tributary; thence to Lake Houston. TCEQ received this application on December 19, 2019.
