**Current Situation**

This contract is a continuation of an existing contract in our portfolio, consisting of ambulances, light/medium rescue vehicles, specialty vehicles or equipment, ems vehicle conversion, and remounts. Four new manufacturers were added covering boats and specialty vehicles. All bid responses have been evaluated by H-GAC staff. Twenty-four bid (consisting of eighty-three vendors) are being recommended for award. Request authorization for contracts representing the best value for product items as summarized in the Award Recommendations Table, and if applicable, to extend contract assignments to other authorized entities during the contract period. If an awarded bidder fails to execute a contract within forty-five days, fails to maintain required licenses, or is determined to be ineligible, authorization is requested to contract with the next lowest responsible bidder. Award is subject to certification of required Texas Motor Vehicle Licensing.
