## **FULL CONTRACT ASSIGNMENT AND ASSUMPTION AGREEMENT**

This Contract Assignment and Assumption Agreement is made by and between the Houston-Galveston Area Council hereinafter referred to as H-GAC, Tri-County Communications LTD (Contractor) at 1421 East Pike Boulevard, Weslaco, TX 78596 and Tri-County Communications, L.L.C., (Assignee) at 1421 E. Pike Blvd., Weslaco, TX 78596-5015.

WHEREAS, Contractor has first made H-GAC aware of the need for a Full Assignment of the original Agreement to the new Assignee. WHEREAS, Contractor entered into a Contract, identified as ID 5127, with H-GAC.

WHEREAS, Contractor wishes to assign the full performance of its obligations under the Contract to Assignee, effective on the Effective Date defined below; for the duration of the contract through the End Date of the Agreement, Jun 30 2022.

WHEREAS, Assignee is willing to accept such assignment, perform as stipulated in the original Contract (a copy of which will be provided to Assignee by Contractor) and comply with all the General and Special Provisions.

WHEREAS, H-GAC is willing to consent to such assignment on the terms stated herein;



NOW THEREFORE, the parties agree as follows:

1. Contractor hereby assigns to Assignee all of its rights and obligations, including payment, under the Contract on the Effective Date (defined below). Contractor will continue to be responsible for all actions taken by Contractor and Purchase Orders (if applicable) processed under the Contract prior to the Effective Date of this Assignment Agreement.
2. Assignee hereby accepts the assignment of Contractor's rights under the Contract, including payment, and assumes all of Contractor's obligations under the Contract from and after the Effective Date. Assignee agrees to perform the duties of the Contractor under the Contract and to comply with all Contract General and Special Provisions commencing on the Effective Date.
3. H-GAC hereby consents to such assignment and assumption.




IN WITNESS WHEREOF, the parties have caused this Full Contract Assignment and Assumption Agreement to be executed by their respective duly authorized representatives.



