LIMITED CONTRACT ASSIGNMENT AND ASSUMPTION AGREEMENT

This Limited Contract Assignment and Assumption Agreement is made by and between the Houston-Galveston Area Council hereinafter referred to as H-GAC, TechOps Specialty Vehicles, LLC (Contractor) at 218 A Log Canoe Circle, Stevensville, MD 21666 and Atlantic Emergency Solutions, Inc., (Assignee) at 12351 Randolph Ridge Lane, Manassas, VA 20109.

WHEREAS, Contractor entered into a cooperative purchasing Contract, identified as FS12-23, with H-GAC for the sale of Fire Service Apparatus (All Types) to various End User governmental agencies participating in H-GAC's Cooperative Purchasing Program; and

WHEREAS, Contractor wishes to assign certain of its rights and obligations under the Parent Contract ID 11568 to Assignee and retain the remainder; and

WHEREAS, Assignee wishes to accept the limited assignment of the Contract; and

WHEREAS, H-GAC is willing to consent to the limited assignment provided that the Assignee agrees to comply with all terms of the Contract;

WHEREAS, This Agreement goes into effect on the date signed by all parties to this agreement (the "Effective Date") and ends 11/30/27. All products or services under this Agreement must be rendered within this performance period.

NOW THEREFORE, the parties agree as follows:

Section 1 Contractor hereby assigns to Assignee all its rights and obligations under the Contract with respect to the following:

Right to sell products/services: TOSV-MTV1113F-01,TOSV-MMV1113F-01,TOSV-LRWA-F9,TOSV-LRWI-F9,TOSV-LRWA-R9,TOSV-LRWI-R9,TOSV-LRWI-GM9,TOSV-MRWA-F16,TOSV-LRWI-F16,TOSV-U-SWAT-F9,TOSV-U-SWAT-R9,TOSV-U-SWAT-GM9, TOSV-MRWAI16,TOSVLRWI-F16,TOSV-MRWA-I16,TOSV-MRWI-I16,TOSV-MRWA-FL16,TOSV-MRWI-FL16,TOSV-GMPU-R1,TOSV-FPU-R1,TOSV-RPU-R1

Right to sell products/services in the following geographical area: Fire Departments in the States Of Delaware, Maryland, Kentucky, North Carolina, Ohio, Virginia, West Virginia, Washington DC

Right to administer Purchase Orders:

Section 2 Assignee accepts the assignment from the Contractor and assumes the obligation to provide the products and services specified in Section 1 and to otherwise perform all applicable obligations of the Contractor under the Contract on and after the Effective Date. Contractor will continue to be responsible for all actions taken by Contractor and Purchase Orders processed under the Contract prior to the Effective Date.

Section 3 Contractor reserves to itself the exclusive right to provide all the products and services described in the Contract, except those specifically assigned to Assignee pursuant to Section 1 hereof.

Section 4 H-GAC hereby consents to such limited assignment and assumption.

Unless otherwise noted, this Agreement goes into effect on the date signed by all parties to this Agreement (the “Effective Date”). All other terms and conditions of the Contract shall remain unchanged and in full force and effect.

IN WITNESS WHEREOF, the parties have caused this Contract Limited Assignment and Assumption Agreement to be executed by their respective duly authorized representatives.


