On February 21, 2022 the Plaintiff, The Vietnam Post-Thuongmai LLC, filed suit against each of the Defendants, Hone Thien Lam and Phuoc Thinh Le, jointly and severally for breach of contract and fraud. In January 2022, both of the Defendants defaulted on a promissory note to pay back \$360,000.00 in installments payment to the Plaintiff. These payments were to pay back Plaintiff for funds that Defendant Hong Thien Lam embezzled while working at Plaintiff's company. The Defendants did not make the payments as agreed and have defaulted on the promissory note. The note is valid and the amount owed is due and payable.
