Health insurance cutoff is looming for many

Jeremy Fritz stopped working as an assistant manager for a fitness center in Carlsbad, California, during the pandemic lockdown in the spring when gyms were first closed.

By the end of April, the company operating the fitness center, Active Wellness, eliminated his health insurance. And in July, he was laid off when it became clear the center where he worked would be closed through 2020. Most of the small company's gyms are still shuttered.

Losing coverage in the middle of the coronavirus crisis, as millions of other Americans have, was like "going into this thunder-

storm without an umbrella," Fritz recalled. Active Wellness put him in touch with an insurance broker, which helped him and his husband sign up for a plan under the Affordable Care Act.

For people like Fritz, as well as those who qualify for Medicaid under the law, "there is still a safety net that wasn't there 10 years ago," said Sara R. Collins, a vice president at the Commonwealth Fund.

But that net is already fraying, with thousands of small businesses that had always expressed difficulty in providing employee health insurance under Obamacare now in far worse trouble because of the pandemic.

Not only are businesses shedding workers, but employers are

also cutting expenses like health coverage, and projections of rising numbers of uninsured have grown bleak.

Tens of millions of people could lose their job-based insurance by the end of the year, said Stan Dorn, director of the National Center for Coverage Innovation at Families USA, the Washington, D.C., consumer group. "The odds are we are on track to have the largest coverage losses in our history," he said.

While estimates vary, a recent Urban Institute analysis of census data says at least 3 million Americans have already lost job-based coverage, and a separate analysis from Avalere Health predicts some 12 million will lose it by the end of this year. Both studies

highlight the disproportionate effect on Black and Hispanic workers.

"There is this expectation that we are going to see big losses in employer-based coverage," Collins said.

Many businesses have tried to keep their workers insured during the pandemic. Employers relied on government aid, including the Paycheck Protection Program authorized by Congress to ease the economic fallout, to pay for premiums through the spring and summer.

Government funding appears to have "prevented the economic crisis from becoming a coverage crisis right away," said Leemore S. Dafny, a professor at Harvard Business School and one of the

authors of a report last month looking at the pandemic's effect on small businesses.

Describing those employers as "the proverbial canary in the coal mine," the researchers say there could be significant coverage losses if insurers and lawmakers fail to act in the coming months. Nearly a third of small businesses surveyed in late June said they were not sure they could keep paying premiums beyond August, according to the report.

"We will probably really start to see it during renewal time, November and December," said Mark Hall, the director of health law and policy at Wake Forest University.

"That will be when the money really dries up."

Route realignments to routes 56, 66, & 89; schedule changes to routes 4, 6, 8, 10, 14, 25, 26, 27, 28, 40, 45, 47, 50, 54, 56, 65, 66, 68, 73, 82, 86, 88, 89, 96, 99, 108, 137, 151, 402, 418, all Park & Ride corridors, and METRO Rail Red, Green, and Purple Lines; and the discontinuation of routes 412 & 413. METRO will continue to make temporary schedule adjustments in response to social distancing and workforce availability.

NOTICE FOR EARLY PUBLIC REVIEW OF PROPOSALS TO SUPPORT ACTIVITY IN THE 100-YEAR FLOODPLAIN AND WETLANDS

To: All Interested Agencies, Groups, and Individuals

This is to give notice that the Harris County Community Services Department (HCCSD) has determined that the following proposed actions under the Hurricane Harvey Community Development Block Grant - Disaster Recovery (CDBG-DR) program are located in the 100-year floodplain and in National Wetlands Inventory (NWI) wetlands and that HCCSD will be identifying and evaluating practicable alternatives to locating the actions in the floodplain and wetlands and the potential impacts on the floodplain and wetlands from the proposed actions, as required by Section 2(a)(4) of Executive Order 11988 for Floodplain Management and by Section 2(b) of Executive Order 11990 for the Protection of Wetlands, in accordance with U.S. Department of Housing and Urban Development (HUD) regulations found at 24 CFR 55, Subpart C, Procedures for Making Determinations on Floodplain Management and Protection of Wetlands.

Post Disaster Relocation and Buyout Program (Golden Gardens). In accordance with approved Post Disaster Relocation Buyout Program guidelines, HCCSD will pursue contracting with landowners for the mandatory purchase of their land in the Golden Gardens neighborhood east of the homes along Darjeen Street, south of Greens Bayou, north of Norments Street, and west of railroad tracks. The 26.3-acre buyout area is located in the north central portion of Harris County, Texas. An estimated 26.3 acres are in the floodplain, all of which are also in the floodway (FEMA FIRM panel 48201C0495L). An estimated 6.6 acres are identified as wetlands according to the NWI.

Post Disaster Relocation and Buyout Program (Highland Shores Phase 2). In accordance with approved Post Disaster Relocation Buyout Program guidelines, HCCSD will pursue contracting with homeowners and business owners for the mandatory purchase of their homes and businesses in the Highland Shores neighborhood along Highland Shores Drive from just west of North Main Street to the east side of Shorewick Drive, the northeast side of Shorewick Drive, and both sides of Bendwick Drive. The 104.7-acre buyout area is located in the eastern portion of Harris County, Texas. An estimated 94.9 acres are in the floodplain, with 85.1 of those acres also in the floodway (FEMA FIRM panels 48201C0730M and 48201C0735M). An estimated 26.4 acres are identified as wetlands according to the NWI.

There are three primary purposes for this notice. First, people who may be affected by activities in floodplains and wetlands and those who have an interest in the protection of the natural environment should be given an opportunity to express their concerns and provide information about these areas. Second, an adequate public notice program can be an important public education tool. The dissemination of information about floodplains and wetlands can facilitate and enhance Federal efforts to reduce the risks associated with the occupancy and modification of these special areas. Third, as a matter of fairness, when the Federal government determines it will participate in actions taking place in floodplains or wetlands, it must inform those who may be put at greater or continued risk.
